President's Report:

- •On October 12th, 2023, Local 3652 received the ACF (Additional Compensation Funds) increase. Unfortunately, not all received that increase. I reached out to Transit and was told to make a list of those employees who did not received their increase. Also, the list was forwarded to labor relation to resolve the issue. Transit and Labor Relation are still working on it, last time I contacted them.
- •On February 29th, 2024, we received the retro, on general rate increase and there no controversy.
- •Our next pay increase on that contract is schedule for May 26th, 2024.
- •In our last general membership meeting, I mentioned that Brother Efrain Perez, our union representative was about to retire, and he's position will be vacant. Brother Perez, was out on medical leave and now he is back with us.

The union wanted two (2) days like other City Agencies, which was written in the contract. However, if Transit agrees to give us one day, we will be satisfied with that.
