• The working condition contract negotiations with the MTA will be finalized on September 27<sup>th</sup>, 2023. As you all are aware of, local 3652 was able to secure the Railroad pass for our members. Now members can easily board the LIRR and Metro North without any hesitation, including express buses for free. Also, the local were able to secure with that contract an increase on longevity and those of our members with service increment will also have an increase.
